Tom S will keep his website up to date, so you can reference it often. This has worked well in the past.

Alison has paid the Park Service for the permit. I have made a 50% down payment of \$9000 to Canyon REO. Our trip is now full. 14 people will do the whole trip. Two people will do the first part and two people will do the second part. We have one person on the waiting list.

Our Grand Canyon River trip will take place in less than three weeks. I expect this to be the last update that I send out an update. Tom will keep his website up to date. We are renting five 18' raft from Canyon REO. By reserving early we saved a significant amount of money. The last few times we have used Canyon REO and have been very pleased with them.

- Please review your individual logistics below. Let me know if I need to make corrections or if you have questions. There are 18 of us and a lot of moving parts. Make sure I have your transportation to the put-in, Lees Ferry and from the take-out, Pearce Ferry. Those doing a partial trip have different logistics.

### Time Line:

December 10, 2018 – 90 days until launch date – anyone added to our permit will be charged an additional \$100 (so \$210) by the National Park Service.

December 10, 2018 – The Park Service has processed our permit.

January 3, 2019 – Tim sent \$9000 - 50% of invoice to Canyon REO

Thursday, March 7, 2019 – If you are flying into Flagstaff you probably want to arrive Thursday evening and stay at the Aspen Hotel.

Friday, March 8, 2019 – You will want to be in Flagstaff at the outfitters by 9:00 am. After Canyon REO's orientation, we will travel to Lees Ferry – the put-in

Friday, March 8, 2019 – Pay Canyon REO remaining balance (\$9000 range)

Friday, March 8, 2019 mid afternoon – We will rig the rafts. When this is complete the ranger will inspect our gear

Friday, March 8 dinner – for those who want to - we will eat at the Marble Canyon Lodge

Friday, March 8 night – Most of us will camp at the boater camp near the put-in at Lees Ferry. If you would like to spend your last night in a hotel you can make reservation at the Marble Canyon Lodge. Rick and Melinda are planning to do this.

Saturday, March 9, 2019 – morning – Ranger talk and the ranger inspection of each person's ID. (make sure you have a valid picture ID available) – LAUNCH!!

Saturday, March 16, 2019 - Exchange at Phantom Ranch

Friday, March 29, 2019 – pass Diamond Creek (mile 226)

Monday, April 1, 2019 – take out at Pearce Ferry (mile 280)

The permit allows 16 participants on the river at any one time. Exchanges are allowed, but park fees (\$110) must be paid for each individual whether you are on the river for 24 days or 1 day.

Cars can be parked here for \$50 for the duration for the trip. (Canyon REO has a third party that will store them for \$40) DA is parking her car there for the first week.

### **Total Cost of Trip:**

I expect the cost of our 24 day trip to be about \$1500 each; for just the first part about \$700; for just the second part about \$1100. This includes all communal equipment, food, shuttle to and from Flagstaff, and park registration fees. It does not include snacks, beer, wine and transportation to Flagstaff. Normally, about a month after our trip, Canyon REO has inspected the equipment and we receive a refund for the damage deposit. At that point, I send a refund to everyone else. It is possible, but unlikely, that I could ask everyone for more money.

# **Open Slots**

The trip is now full. One person is on the waiting list. Any additional people that would like to go will be placed on the waiting list.

# **Trip Structure:**

Alison is the permit holder. From the National Park Service's (NPS) perspective she is the trip leader and is legally responsible for all of our behavior. If Alison does not go, none of us can go. I am the "qualified boat-operator" (NPS term) and I am responsible for knowing the river, the equipment and assuring that

we have the experience as a group to be on the river. From a practical perspective, I am the coordinator and leader of the group as a whole with a lot of help from Tom Strauch. Tom is coordinating the food. We will have only one food group.

#### **Car Shuttle**

The car shuttle by Canyon REO from Flagstaff to the Pierce Ferry take-out is \$185. The shuttle cost from Lees Ferry to Flagstaff is \$150. The storage fee (third party from Canyon REO) is \$40.

### Logistic for the start of the trip (subject to frequent changes):

The eleven of us that will be in Flagstaff Thursday night will need to be at Canyon REO in Flagstaff by 9:00 am on Friday, March 8 for Canyon REO's orientation to their equipment. Their orientation is very worthwhile. Tom Strauch, who has attended this orientation multiple times, prefers to drive directly to the put-in at Lees Ferry, and then have his car shuttled to Pearce Ferry. Alison and Ross will travel with him. Melinda and Rick will also go directly to Lees Ferry. Most of us will be at the Aspen Hotel on Thursday, March 7. It is a good base and people can consider arriving even earlier and staying extra days in Flagstaff. It is helpful to all of us to know each other individual plans. If you are flying, and someone is already in Flagstaff they might be able to pick you up at the airport. If you are driving, you might car pool with other people that are driving. If you have questions about the put-in, Flagstaff or take-out, please ask. I have had much experience with many different options. After the Canyon REO orientation we will drive to Lees Ferry. Currently Mark, DA, Bo, Brian and AJ will have cars in Flagstaff. There will be 11 of us there. The Canyon REO equipment truck can take 3 or 4 people at no additional charge. The rest can travel in Bo's and Mark's cars to Lees Ferry. These cars will be shuttled back to Flagstaff. All of our personal equipment may be placed in the equipment truck.

Once at Lees Ferry we will rig the rafts. The ranger will inspect our gear. We will have dinner at Marble Canyon Lodge and then spend the night at the boater's camp near the put in.

### Logistic for the exchange at Phantom Ranch (subject to frequent changes)

DA and Josh will be hiking out on the Bright Angel trail and Kristi and Dan will be hiking in on the morning of March 16. Kristi and Dan will park the cars in the El Tovar Hotel parking lot. DA's key will be at the Aspen Hotel's front desk and Kristi and Dan will leave their keys at the El Tovar front desk.

# Logistic for the end of the trip (subject to frequent changes)

We will be taking out at Pearce Ferry. Alison, Mark, Brian, Bo and Dan will have their cars shuttled there. A friend is driving Melinda's car there. This is far more convenient for all of us heading west and north rather than returning to Flagstaff. The equipment truck expects to show up around 11:00 am. By that

time we should have all the boats derigged. It should take us less than two hours to load the truck and be on our way. Canyon REO does not need us to help unload the equipment in Flagstaff. Please let me know if you will need a ride back to Flagstaff. Canyon REO has room for up to five passengers in the equipment truck. If we shuttle five cars there would be no room for any of us to go back to Flagstaff (the five shuttle drivers would need a ride back). The current plan is that we will have five cars shuttled and Dan will drive his car with AJ and anyone else who want to go back to Flagstaff. If you are flying, you should plan to fly out of Las Vegas. It should be safe to catch a flight on Monday, April 1 at 7:00 pm or later. (It is about 2 ½ hours to Las Vegas and the first of our cars should be driving through Vegas by midafternoon, however there can be traffic jams in Vegas and shit does happen on the river.) Any one driving directly back to Oregon and Washington will be going through Vegas and could drop you off at the airport.

**Tim**– Drive with Melinda and Rick to Lees Ferry, leaving Tuesday March 5. AJ will caravan with them. Rick and Melinda will stay at Marble Canyon Lodge. Tim and AJ would continue on to Flagstaff. Tim is staying at the Aspen Hotel. From Pearce Ferry, Melinda will give Tim, Polk and Kristi a ride to La Quinta Inn & Suites Las Vegas Airport South. Tim will share a room with Polk and fly out on April 2. Dan will take most of Tim's and Rick's gear and drop it off in the Tri-Cities sometime in April.

**Rick** – Drive with Melinda and Tim to Lees Ferry, leaving Tuesday March 5. AJ will caravan with them. Rick and Melinda will stay at Marble Canyon Lodge for two nights March 7-9. Rick's wife will fly to Vegas on March 30 to visit her brother. Ric will ride with Bo to Las Vegas and will stay with his brother-in-law and then fly back with his wife. Dan will take most of Tim's and Rick's gear and drop it off in the Tri-Cities sometime in April.

**Melinda** – Plans to drive from Richland, WA to Lees Ferry. She would leave Tuesday, March 5. Rick and Tim will travel down with her. AJ is caravanning with us. Rick and Melinda will stay at Marble Canyon Lodge for two nights March 7-9. Her car will be shuttled from Lees Ferry to Flagstaff. Friends of her will drive her car from Flagstaff to Pearce Ferry. She will not come back immediately to Richland after the trip. She plans to drive to Las Vegas and will drop Tim, Kristi and Polk off at the La Quinta Inn & Suites Las Vegas Airport South. She will then spend two weeks in southern Utah. Jan 2 - My friends have agreed to pick up my car in Flagstaff and deposit it at Pearce Ferry before in time for our arrival April 1. They are quite flexible. So thats committed.

**Tom, Alison and Ross** – Alison and Ross will drive in Alison's car to Salem to pick up Tom. They will then drive to Lees Ferry. From Pearce Ferry they will do the 17 hour drive back to Salem in time for Tom to go to work on April 2.

**Bo** – Plans to drive from Highland, IL (near St Louis). He will drive to Flagstaff and stay at the Aspen Hotel Wednesday and Thursday. His car will be shuttled to Pearce Ferry. He will give a ride to Rick and Bill to Las Vegas. Sharon, Bo's spouse, will fly to Vegas the day before.

Mark and Ted – will drive together from southern California to Flagstaff. Ted and I will be arriving on Thursday in Flagstaff and will be staying at the Aspen Hotel. I will be driving a Subaru Forester. All the car shuttle plans sound good to me. If needed, at the end of the trip they can take two more people to the Las Vegas airport on his way home.

**Polk** – Will fly into Flagstaff on March 7 and stay at the Aspen Hotel. After the trip will ride with Melinda to Las Vegas. He will share a room with Tim at the La Quinta Inn & Suites Las Vegas Airport South and fly out on April 2.

**Brian** – will be in Eugene, Oregon. Plans to drive to Las Vegas. Ben will be flying into Las Vegas in March 3, and we planned to stay two nights leaving March 5. From there we are open about the couple of days before driving to Flag, I have an uncle in havasu city and a friend in flagstaff. If anyone else wants to fly in those days to Vegas, we can pick them up. Drives a Subaru sedan. I do have extra camp tents, pads and sleeping bags. After the trip will give a ride to Ben to Las Vegas.

**Ben** – I am planning flying into Vegas on March 3 or 4. Brian is most likely going to meet me there between March 4 and March 6. He will be coming from Oregon. So if for any reason along that path someone on the trip needs a ride he said he is available. Brian and I plan to be in Flagstaff the night of the 7th. We will be there for the orientation. After the trip Ben will get a ride from Brian back to Las Vegas.

AJ – Plans to drive to Pasco on March 4 and stay with Tim. She will caravan down to Marble Canyon with Melinda, Ric and Tim. AJ and Tim will continue on to Flagstaff and arrive on March 7. After the trip she will ride back to Flagstaff with Dan to pick up her car. AJ will also have a couple of weeks after the rafting trip before AJ starts back at her regular interpretive ranger position, so she will drive down herself and take her time visiting friends, etc. on the way back.

**Bill** - Is flying into Flagstaff on March 7 and out of Las Vegas probably on April 2. Will ride with Bo from Pearce Ferry to Las Vegas.

**DA** – doing the first part. I will plan on meeting group in flagstaff Thursday night. I have Prius which seats driver + 3 others. Not sure if it will fit 4 people + their gear. Another piece of my plan is to spend Saturday night, March 16, at the el Tovar at south rim before driving back to Santa Rosa Sunday morning.

**Josh** – doing the first part. He will be flying to and from Flagstaff. On March 7 he will be staying with Rick at the Aspen Hotel. After he hikes out he will drive Dan's car back to Flagstaff and fly out the evening of March 16. He will drop Dan's car at Canyon REO and needs to be there before 4:00 pm. They will give him a ride to the airport.

**Kristi** – doing the second part. Plans to fly to Phoenix and ride up with Dan to Flagstaff. She will pick up DA's car at the Aspen Hotel and drive it from Flagstaff to the South Rim. She will park DA's car at the El Tovar Hotel. After the trip will catch a ride with Melinda to Las Vegas, stay at La Quinta Inn & Suites Las Vegas Airport South and fly out on April 2.

**Dan** – doing the second part. Plans to drive from Phoenix to the South Rim. He plans to give a ride to Kristi from Phoenix to Flagstaff. Dan will stay at the Grand Canyon Plaza Hotel near the South Rim. He will park his car at the El Tovar hotel and leave his keys at the front desk. Josh will drive his car to Flagstaff. His car will be shuttled from Flagstaff to Pearce Ferry. He will drive back to Flagstaff with AJ and anyone else that needs a ride back to Flagstaff.

### **Logistics by Car:**

**Melinda's**: Ric and Tim will drive with her from the Tri-Cities to Marble Canyon. Ric and Melinda will stay at the Marble Canyon Lodge for two nights (March 7-9). Melinda's car will be shuttled to Flagstaff. Her friend will pick up her car in Flagstaff on March 30 or 31 and meet us at Pearce Ferry on April 1. Melinda will drive Tim, Polk and Kristi to La Quinta Inn & Suites Las Vegas Airport South. (Needs: shuttle Lees Ferry to Flagstaff, store car in Flagstaff)

**Melinda's friends'** (Mike Cline and Jane Sumerson): Will pick up Melinda's car in Flagstaff and drive it to Pearce Ferry. (Needs: none)

**AJ's:** will drive to Pasco by March 4. Will caravan with Melinda, Ric and Tim to Marble Canyon Lodge. AJ and Tim will continue on to Flagstaff and stay in the Aspen Hotel. After the trip she will get a ride from Pearce Ferry to Flagstaff from Dan. (Needs: store car in Flagstaff)

**Alison's:** Alison and Ross will drive to Tom's after Ross gets off work on Wednesday, March 6 (Tom also plans to work Wednesday). They will drive to Lees Ferry. The car will be shuttled to Pearce Ferry. (Needs: store care in Flagstaff, shuttle from Lees Ferry to Pearce Ferry)

**Brian's:** Will drive to Las Vegas to meet Ben. They will drive on to Flagstaff. The car will be shuttled to Pearce Ferry. They will drive to Las Vegas. (Needs: store care in Flagstaff, shuttle from Flagstaff to Pearce Ferry.)

**Mark's**: Will drive with Ted to Flagstaff. Will stay in the Aspen Hotel. He will drive to Lees Ferry with Tim, AJ and Ted. The car will be shuttled from Lees Ferry to Pearce Ferry. (Needs: store car in Flagstaff, shuttle from Lees Ferry to Pearce Ferry.)

**Bo's:** Will drive to Flagstaff and stay at the Aspen Hotel on March 6-8. He will drive to Lees Ferry with DA, Bill and Polk. The car will be shuttled to Pearce Ferry. Bo will give a ride to Ric and Bill to Las Vegas. (Needs: store car in Flagstaff, shuttle from Lees Ferry to Pearce Ferry.)

Canyon REO equipment Truck: Josh, Brian and Ben will ride from Flagstaff to Lees Ferry.

**Dan's**: (second part of trip) will pick Kristi up at the Phoenix airport and drive to Flagstaff on March 15. Kristi will pick up DA's car from the Aspen Hotel and they will both drive to the South Rim. DA will hike out and pick up her car. Josh will pick up Dan's car and drive it to Canyon REO by 4:00 pm and they will give him a ride to the Flagstaff airport. Josh has an evening flight out. The car will be shuttled to Pearce Ferry. Most of Tim's and Rick's gear will be loaded into Dan's car. Dan will drive back to Flagstaff with AJ. Dan will drive through the Tri-Cities sometime in April and Tim and Rick will retrieve their gear. (Needs: shuttle from Flagstaff to Pearce Ferry, store car in Flagstaff)

**DA's:** Will drive to Flagstaff and stay at the Aspen Hotel. She will park her car there. Kristi will pick up her car at the Aspen Hotel, drive it to the South Rim and park it at the El Tovar Hotel. (No needs)

**Summary of needs (for which we will pay Canyon REO):** 8 cars stored in Flagstaff (does not include DA's), 1 shuttled from Lees Ferry to Flagstaff; 3 shuttled from Lees Ferry to Pearce Ferry; 2 shuttled from Flagstaff to Pearce Ferry)

### Daylight:

In March we will have 11-13 hours of daylight. We will want to take advantage of the daylight hours by getting up and starting early.

# Hiking:

On all river trips, there are those who like to hike and there are those who prefer to relax and hang out in camp. Grand Canyon trips can accommodate both and everything in between. Our group is very oriented toward hiking.

### **Camp Chairs:**

I feel that one of the most important items to bring along on the trip is a camp chair. It represents your personal space at camp and around the camp fire. For some unknown reason, on the few trips that I have been on that had less chairs than people, there have been disagreements about chairs and space. Please bring your own camp chair.

### **Equipment:**

The outfitter will supply almost all of the river equipment, including an ammo can for each of us. Unlike 2016, Canyon REO will not supply extra dry bags and life jackets. Most of us have our own river gear. Please let me know if you do not or if you have extra that you can share. I have about 5 large dry bags that I can share. Canyon REO will rent both life jacket and a large dry bag for \$25 each for the whole trip. For the most part you should be able to get your personal gear in one large dry bag, or two medium ones. This does not include tents or chairs.

I strongly recommend Aquaphor, a skin ointment for your hand and feet. Your hand and feet will become cracked and dry as a result of being wet most of the time. Wearing gloves can also help your hands. It is recommended that you start using Aquaphor a week before the trip to moisturize your hands and feet.

Wet suits and dry suits are not included as part of the equipment. It is a good idea to bring one or the other if you have them. At this time of year they are good to have but not necessary. You will want clothing that will keep you warm when you are wet. The Outfitters may have used wetsuits that they will sell at discounted prices. It is likely that we will have some very hot days, but we could also have some cool ones.

### Snack, drinks, beer and wine

Even though the outfitter will supply us with plenty of food you may still want to bring your own snacks. There is plenty of space so you can bring as much as you want of drinks. Do not bring any glass. Soda and beer should be in cans and wine in bags (a small glass container of hard liquor is OK). There will be plenty of filtered water and everyone is encouraged to drink plenty of water. If you prefer to bring your own drinks up to four or five cases is acceptable.

### **NPS Registration:**

Although it is apparently not yet necessary for participating, I would recommend that everyone creates a profile at: <a href="https://npspermits.us">https://npspermits.us</a>. Most all of us have done that when we applied for the lottery.

# **NPS Regulations:**

Can I change my passenger list or gear after sending you my trip application?

Participant names may be changed online before launch. Before going to Lees Ferry, ensure that each participant will have picture ID and the total number of participants (including the permittee) does not exceed 16 at any one time (8 for a small trip). The trip leader must be present the entire trip. You may change or add boats at Lees Ferry. Just be sure to show up with the required gear associated with the additions. Between 30 and 90 days before launch, the trip leader will be allowed to request that additional trip participants be added to the trip. For these late additions there will be the normal \$110 charge per added person plus an additional late fee of \$100 per added person. Trip participants may not be added within 30 days of launch.
